Telehealth Patient Consent

This consent is to inform you of your rights for privacy with respect to your health care information in accordance with HIPAA regulations, ZenBees Psychiatry & Wellness Services, LLC. has implemented strict privacy and security precautions to protect its patients' health information.

Telehealth service involves the real-time evaluation, diagnosis, consultation on, and treatment of health care condition(s) using advanced telecommunications technology, including interactive audio & video. Electronic systems used have network and software security protocols in place to protect the confidentiality of patients' information.

ZenBees Psychiatry & Wellness Services, LLC. offers telehealth services to its patients to improve access to health care by enabling a patient to remain at home (or at a remote site) while receiving care from a distance. Telehealth sessions should be conducted confidentially. You will need to find a space that is private, without interruption, and without other people present.

During the telehealth appointment, details of your medical history and current condition may be discussed by interactive audio-video technology. ZenBees Psychiatry & Wellness Services, LLC. rely on information provided by you and it is your responsibility to provide information about your medical history, condition, and care that is complete and accurate to the best of your ability. ZenBees Psychiatry & Wellness Services, LLC. advice, recommendations, and decisions may be based on factors not within their control, such as incomplete or inaccurate data provided by you or distortions of audio/video during the telehealth visit. ZenBees Psychiatry & Wellness Services, LLC. has the right to determine if a telehealth appointment is appropriate for your needs and may recommend an in-person appointment.

ZenBees Psychiatry & Wellness Services, LLC. does not warrant that its telehealth services will be compatible with any updates to, or prior versions of, your devices' operating systems. To the extent that your telehealth appointment requires the use of wireless, cellular data, or internet access, you are responsible for securing the necessary data access service. e.g., your mobile phone provider may charge you data access fees in connection with your use of telehealth services. You are solely responsible for all such charges payable to third parties.

In the event of interruption or disconnection of the audio/video connection, the continuity or completion of a particular telehealth visit will depend upon whether the information transmitted is sufficient for the patient's condition. If the audio/video connection is inadequate for that purpose or is disconnected, ZenBees Psychiatry & Wellness Services, LLC. may require an in-person visit. Your health information will be transmitted electronically by audio and video; however, the security and confidentiality of information transmitted electronically may be compromised by the failure of these security safeguards or illegal or improper tampering.

While ZenBees Psychiatry & Wellness Services, LLC. has taken reasonable and appropriate efforts to eliminate any confidentiality risks associated with your telehealth appointment, ZenBees Psychiatry & Wellness Services, LLC. cannot control your environment or any company you may have with you during the telehealth appointment.

All existing State and federal laws regarding the privacy and security of your medical records apply to this telehealth appointment, as detailed in ZenBees Psychiatry & Wellness Services, LLC. Notice of Privacy Practices. In accordance with HIPAA, ZenBees Psychiatry & Wellness Services, LLC. will not record or store any video, images, or audio of your telehealth appointment, and by signing below you agree not to record or store any video, images, or audio of your telehealth appointment. Your provider will document the medical information conveyed during the appointment into your medical record the same as if it was an in-person office visit. You have the right to obtain copies of your medical records; any requests to inspect and obtain copies of medical records associated with telehealth will be made in accordance with ZenBees Psychiatry & Wellness Services, LLC. standard policies and procedures.

Billing: By signing below, you understand that your insurance will be billed for any telehealth services you receive from ZenBees Psychiatry & Wellness Services, LLC.; you may be billed for what your insurance does not cover; and you have been advised to check with your insurance carrier for coverage of telehealth visits. If your insurer does not cover telehealth visits, then you will be responsible for the full fees for telehealth services you receive from ZenBees Psychiatry & Wellness Services, LLC. If you have any questions about your billing, you should contact ZenBees Psychiatry & Wellness Services, LLC. office.
